Purpose

This briefing provides you with a draft Cabinet paper seeking approval to include amendments to the Immigration Act 2009 in an upcoming Omnibus Bill, for discussion with officials.

Background

- 1. On Wednesday 15 April, the COVID-19 Ministerial Group will consider a Cabinet paper outlining proposed law changes in response to COVID-19. That Cabinet paper proposes that a second Omnibus Bill be progressed as soon as possible after the House resumes.
- 2. If the COVID-19 Ministerial Group agrees to progress the Omnibus Bill, it currently appears likely that it will be introduced the week commencing 27 April 2020, or failing that, the week following. In order to meet either deadline, early policy decisions are needed as to whether any amendments to the Immigration Act 2009 should be included in the Omnibus Bill.

An early draft Cabinet paper is attached for your consideration

3. Officials discussed a list of possible amendments with you on Monday 6 April 2020, and at this stage we recommend that eight of those amendments continue to be progressed. We note that two other possibilities that were raised – removing the requirement for oaths to be sworn at a court, and updating warrant of commitment timeframes – are not included, as more work is needed to determine if they are appropriate to deal with by way of an Omnibus Bill.

The amendments cover a range of areas but all would increase flexibility

4. The proposed amendments are listed below with the detail of these discussed in the draft Cabinet paper in Annex One. Some of them are relatively minor (for example, removing the requirement to provide a physical address for service) while some could be very far reaching, such as the power to vary visa conditions across entire classes of people. While far reaching, this particular new power could have be n used, for example, to place requirements to obey the directions of a Medical Officer of Health relating to a notifiable infectious disease on existing visa holders ra her than just new visa applicants.

Proposal two: The power to extend the expiry date of visas for a class of people

Proposal three: The power to grant visas to individuals and classes of people in the absence of an application

Proposal four: Removing the requirement for visa applicants to provide an address for service

Proposa six: The power to waive, in an individual case, the requirement to obtain a transit visa

We are working through details with MBIE Legal and external agencies

- 5. In addition to teasing out the specific detail of the proposed changes, we are seeking to ensure that
 - there are appropriate levels of delegation for each proposed power (some will be nondelegable i.e. only able to be exercised by the Minister)

- the specific mechanism for giving effect to the proposal is appropriate, for example should the power be exercised by a modified form of special direction or some other instruction, and
- the levels of public and parliamentary scrutiny that will be appropriate when using the new power (for example, some being required to be published in the Gazette and on the Ministry's websites).

It is possible that some of those amendments will not require formal Cabinet approval

6. Depending on the decisions made by the COVID-19 Ministerial Group on 15 April, some of the proposed amendments may not require Cabinet agreement. In that case, your agreement to them (through your response to the recommendations in this paper) will be sufficient for drafting instructions to be prepared for PCO.

It is possible that a different vehicle could be used for some of those amendments

7. We understand that a proposal to review and extend the Epidemic Preparedness Act 2006 is currently being developed. If this proceeds, it is possible that some of the Immigration Act amendment proposals could potentially be moved across to that work We will keep your office advised of any changes.

We are consulting at speed with interested agencies
