

Registration of interest: Managed Return from New South Wales

Who is eligible to register?

People who meet the criteria below who are stranded in NSW are eligible for managed return flights. They may also travel with their partner and dependent children:

- You are a New Zealand citizen.
- You are a New Zealand permanent resident or resident visa holder.
- You are a citizen of Australia or person who holds a current permanent resident visa (including a resident return visa) issued by the Government of Australia, who is ordinarily resident in New Zealand.
- You are a holder of a New Zealand temporary visa, who is ordinarily resident in New Zealand.

AND

- You travelled to New South Wales between 6 April and 22 June during quarantine-free travel with New Zealand.

AND

- You had a flight booked, or intended to book a return flight, to New Zealand but were unable to travel due to the travel pause with New South Wales.

All travellers will enter a Managed Isolation Facility for a period of 14 days following their entry into New Zealand. You will not be required to pay.
